Grand Knight's Report

I attended the 113th annual Virginia State Convention in Roanoke April 26-28. A requiem Mass was said for the souls of the Brother Knights who passed away throughout the state this past year to include: Donald Firer, Henry "Buz" Goforth, SK Nathaniel Long, and SK Conrad Isak. Nominations and elections will be held on May 20th for new officers. An open officer's meeting will be held on May 6th. No speakers or entertainment has been scheduled for that evening. All council members are invited to attend.

As a gesture for the year of faith, I would like to purchase inexpensive rosaries (\$24.95) and inexpensive Miraculous Medals (\$49.95) and order Knights of Columbus rosary guides to be passed out to our fellow parishioners (with our Pastor's permission of course).

After consulting with Bob Maher, this is what he said we need to do about possible 3rd degree exemplifications in Charlottesville. 3rd degrees are planned well in advance, so we need to check the state schedule to see where we possible fit in the schedule. We need to contact the principle of Charlottesville Catholic School and request the gym, kitchen, and two classrooms. One month prior to the Degree, the District Deputy needs to send invitations to the other districts. The Grand Knight needs to receive RSVPs. As host council, we need to have at least 11 people to help with food, setup, and takedown. Our council's KOVAR collections went well. Holy Comforter collected \$125 after the Masses. On April 21st, we collected roughly \$690 at the pancake breakfast at Church of the Incarnation. Thanks to Norm Balwinski for leading this effort. Other volunteers included Bill Phillips, Jesse Boeckermann, Larry Hance, Bob Marinchick, Mike Cerrutti, Curtis Bean, Frank O'Donnell, and me. Thanks to the wives for helping out. \$1600 was donated to KOVAR this year. There are some local organizations that are requesting fundraising assistance, including Camp Holiday Trails and Without Boarders. CHT provides a free camp experience for children with a variety of handicaps, such as asthma, amputations, cystic fibrosis, etc. They need to renovate the camp barracks. We voted to give the proceeds of our Communion Breakfast at Holy Comforter, \$312, to Camp Holiday Trails at our last business meeting in April. Without Borders requested that we hold a pancake breakfast on their behalf. Without Borders was told that we would be able to assist them after the summer. Our council also donated \$122 to Virginia Knights of Columbus

ELLIS FLINN

A funeral mass was held for Ellis Flinn on April 18 at St. Thomas Aquinas Catholic Church. Ellis Dean Flinn was born on December 22, 1934 in Woodward, Iowa, and died on April 6, 2013, with his family by his side.

Ellis is survived by his wife of 55 years, JoAnne; by his son, Kelton Flinn and his wife Colette Hall, of Charlottesville; and daughter Keri Flinn Smallie, of Richmond; his grandchildren, Benson and Shannon Smallie; and his sister, Doris Cavanaugh.

Ellis was the first in his family to attend college, Drake University in Des Moines, Iowa. After college, he served in the U.S. Army. He married JoAnne Engel at the chapel on Fort Meade on August 19, 1957. After his service, they settled in Pittsfield, MA, where both children were born. He became the youngest office that Berkshire Life Insurance Company ever had. The family moved to Washington, D.C. in 1967, where Ellis was a life insurance actuary with the Wyatt Company. Ellis was a Member of the American Academy of Actuaries, a Fellow of the Society of Actuaries, and a Fellow of the Canadian Institute of Actuaries.

One of his major clients was the Knights of Columbus and in 1982, he and JoAnne moved to New Haven, Connecticut, when Ellis became Deputy Supreme Knight of the Knights of Columbus and Chief Operating Officer of their insurance program.

As Deputy Supreme Knight, he and JoAnne travelled to the Holy Land, Rome, and to many other fascinating places. They met Pope John Paul II on several occasions, and Ellis was awarded the Equestrian Order of St. Gregory the Great by the Pope for conspicuous service to the Catholic Church. They also met Mother Theresa. Ellis was truly dedicated to the Knights of Columbus and after he retired and moved to Charlottesville, he was very active with the Council at the University. He loved working with and mentoring the young men.

Ellis loved to travel and took the family on many spectacular trips, including to China. When the grandchildren were young, he would annually take the whole family on a cruise.

Carol's dad passed away in September. Her mom passed in 2009, so all the estate planning issues came into play.
